

**Recruitment and Participation Regulations for the Course
“Introduction to Integrated Semiconductor Electronic and Photonic
Systems”
(ENHANCE Learning Campus – ELC)**

1. General information

- 1.1. Warsaw University of Technology (WUT) is a beneficiary of the "SPINAKER programme – Intensive International Education Programmes", financed by the European Union under the European Funds for Social Development 2021-2027 (FERS), within a NAWA project entitled "Support for the creation and implementation of international education programmes", project No. FERS.01.05-IP.08-0436/23.
- 1.2. The main goal of the SPINAKER programme is to increase WUT's internationalization by developing an Intensive International Education Programme and implementing it within the project entitled "ENHANCE Learning Campus (ELC) – development of the international offer of Warsaw University of Technology".
- 1.3. The Project is implemented in accordance with Grant Agreement No. BPI/SPI/2024/1/00050/U/00001, concluded between the National Agency for Academic Exchange and the Warsaw University of Technology.

2. Course information

- 2.1. The course "Introduction to Integrated Semiconductor Electronic and Photonic Systems" (hereinafter: the "Course") is a short, intensive course implemented within the project "ENHANCE Learning Campus (ELC) – development of the international offer of Warsaw University of Technology".
- 2.2. The Course will be delivered by the Faculty of Electronics and Information Technology, Institute of Microelectronics and Optoelectronics of Warsaw University of Technology (hereinafter: the "Organizer").
- 2.3. The Course will be conducted in English in a hybrid format from 1 May 2026 to 31 July 2026.
- 2.4. The Course is intended for students and PhD candidates who, after a successful recruitment process, will be referred to as the "Participants".
- 2.5. Participation in the Course is free of charge. Selected Participants may be eligible for financial support in accordance with Section 5, subject to meeting the requirements set out in Section 4.
- 2.6. The maximum number of Participants is 20 (15 students and 5 PhD candidates).

2.7. The Course carries **4** ECTS credits. Participants who meet all academic and attendance requirements will receive a Certificate of Participation and, where applicable, a Diploma.

3. Recruitment rules

- 3.1. The recruitment process for Participants will be carried out in accordance with the schedule published on the Course's dedicated website.
- 3.2. Recruitment will be conducted in an impartial, open, transparent, and equal manner for all candidates, in accordance with the principles of equal opportunities and non-discrimination, including accessibility for persons with disabilities and equal opportunities for women and men.
- 3.3. Enrolment will be completed via the online registration system on the Course's dedicated website.
- 3.4. The selection criteria include:
 - 3.4.1. Quality of the motivation statement.
 - 3.4.2. Balanced representation of participant groups (students and PhD candidates), while maintaining the target composition of 15 students and 5 PhD candidates.
- 3.5. Applicants must demonstrate an English language proficiency level of at least B2 according to CEFR (see: <https://www.coe.int/en/web/common-european-framework-reference-languages/level-descriptions>).
- 3.6. A ranking list will be created based on the submitted CVs and motivation statements. Decisions will be made by a Recruitment Committee appointed by the Organizer. If the number of applications exceeds the number of available places, a reserve list will also be created.
- 3.7. Candidates selected for participation in the Course will be notified by email.

4. Participation rules and obligations

- 4.1. Each selected Participant must confirm participation by the date indicated in the acceptance message.
- 4.2. Participants who wish to receive financial support must submit an application in the FERS application system within 7 days of being informed of their qualification for the Course. The user guide to the application system will be provided on the Course's dedicated website. Failure to submit the application within the deadline means that the Participant will not be considered for financial support.
- 4.3. In the event of insufficient applications, withdrawals, or other justified reasons, the Organizer may initiate supplementary recruitment.
- 4.4. Participants are obliged to attend all online and on-site sessions (unless excused by the Organizer for documented reasons), actively participate in lectures, hands-on

activities, and discussions, and complete all assignments by the deadlines set by the teaching staff.

- 4.5. Participants must comply with the Organizer's rules and respect fellow participants and teaching staff.
- 4.6. After completing the Course, Participants are required to complete an evaluation questionnaire/survey.
- 4.7. In the event of withdrawal or failure to participate without a justification accepted by the Organizer, the Organizer may inform the Participant's home institution and may exclude the Participant from future activities organized within the project.
- 4.8. The Organizer does not provide any form of insurance. The Organizer recommends purchasing health insurance covering the stay in Poland and travel to/from Poland, as well as personal accident and third-party liability insurance, and insurance against loss or theft of documents, travel tickets, and luggage.
- 4.9. The Organizer may take photographs and record video during the Course for documentation, reporting, and promotional purposes related to the Organizer and the ENHANCE Alliance. Where required by applicable law, the Organizer will obtain Participants' consent separately and inform Participants of their rights (including the right to withdraw consent with effect for the future and/or to object to processing) and of the processing of their personal data in accordance with the GDPR.

5. Financial support

- 5.1. Participation in the Course may be financially supported by the Organizer for Participants who:
 - 5.1.1. Attended and participated fully in all components of the Course, both online and on-site.
 - 5.1.2. Complied with all formal and administrative requirements communicated by the Organizer (including requirements related to mobility settlement, where applicable).
- 5.2. Financial support is available to Participants during their stay in Poland only and only in connection with participation in the on-site part of the Course.
- 5.3. Participants will receive support after completing the Course, submitting all required settlement documents, and signing a financial agreement specifying the scholarship amount and the period and terms of payment.
- 5.4. Payments will be made by bank transfer in Polish zloty (PLN) to the bank account indicated by the Participant.
- 5.5. The financial support consists of fixed amounts for scholarship, living and accommodation, and travel, as set out in the table below.
